Bylaw No. 433/07  
A Bylaw of the Town of Spiritwood, Saskatchewan  
Permitting the Use of All Terrain Vehicles

The Council of the Town of Spiritwood, Saskatchewan enacts as follows:

1. Under Section 9 of the *All Terrain Vehicles Act*, All Terrain Vehicles shall be permitted to operate on all Streets, Avenues and Lanes within the boundaries of the Town of Spiritwood subject to the following conditions:
  - a) "All Terrain Vehicles" means a self-propelled vehicle that:
    - i) is designed primarily for the movement of people or goods on unprepared surfaces; and
    - ii) has wheels in contact with the ground;and includes:
    - iii) a restricted use motorcycle;
    - iv) a mini-bike; and
    - v) an all terrain cycle
  - b) All Terrain Vehicles must take the most direct route to or from the point of origin or destination within the Town of Spiritwood to or from the Town of Spiritwood corporate limits, unless the operator of the All Terrain Vehicle is performing one of the following acts:
    - i) Removing snow from streets, lanes, driveways or parking lots
    - ii) Spraying lots with a pesticide, if the All Terrain Vehicle is being operated by a licensed pesticide applicator;
    - iii) Taking part in a parade, ceremony or special occasion that has prior written approval from the Town of Spiritwood Council;
  - c) Each operator who operates an All Terrain Vehicle must hold a valid Drivers License and must be able to provide proof of insurance;
  - d) Each Operator who operates an All Terrain Vehicle must wear a proper helmet as prescribed by the *All Terrain Vehicles Act*;
  - e) All Terrain Vehicles while driving in the Town of Spiritwood must not exceed 24 kilometers per hour and must operate in a safe and courteous manner;
  - f) No person shall operate an All Terrain Vehicle within the Town of Spiritwood between the hours of 11:00p.m. and 7:00a.m.;
  - g) No person shall operate an All Terrain Vehicle on public lands that constitute public parks, school grounds or public parking lots;
  - h) No person shall operate an All Terrain Vehicle on Main Street unless to cross Main Street by the shortest and most direct route, or to perform an act as set out in Section 1(a)(i),1(a)(ii),or1(a)(iii) of this act;
  - i) Anyone operating an All Terrain Vehicle within the Town of Spiritwood who contravenes, or fails to comply with, the provisions of the *All Terrain Vehicles Act*, its regulations or other municipal bylaws is guilty of an offense and subject to the penalties set forth in the *All Terrain Vehicles Act*, the *Highway Traffic Act* or Municipal Bylaws;
2. Bylaw No.369 of 1999 shall hereby be repealed;
3. This Bylaw shall come into force and take effect upon final approval of the Council of the Town of Spiritwood;
